- The final design of the park on West Case is in progress. Construction begins in Spring 2025.

 Road is planning to have K-5 students beginning in Fall 2024, the request for sidewalks could
 be resubmitted to City Council.

Mid-Ohio Regional Planning Commission (MORPC)

MORPC is a regional council of 85 local governments and community partners. Utilizing data analysis, community resources and long-range planning, it developed the draft 2024-2050 Metropolitan Transportation Plan (MTP). The MTP identifies priority transportation infrastructure needed in the central Ohio region for the next 25 years. The central Ohio region includes Franklin and Delaware counties, and parts of Licking, Fairfield, and Union counties. The infrastructure will address pedestrian, bicycle, and transit needs.

As part of the MTP's development process, MORPC staff are giving presentations at community meetings. The PowerPoint presentation is posted on our web site at www.northwestcivic.org under Meetings & Events. The public is invited to review the proposed projects on an interactive map: (https://www.morpc.org/2024-2050-metropolitan-transportation-plan/) so they can identify locations with safety, congestion or connectivity issues, and suggest their own ideas and projects. Feedback collected through these meetings, sent via webmap comment, or sent directly to MORPC staff through March 31st will be incorporated into the final document before its scheduled adoption in May 2024.

On a related topic, MORPC is one of the sponsors of LinkUS, a collaborative initiative also sponsored by the City of Columbus, COTA (Central Ohio Transit Authority), and the Franklin County Board of Commissioners. A proposed additional .5% COTA sales tax will be on the November ballot. It would be used for implementation of LinkUS in the COTA service area - Franklin County, a small part of Licking County, and the Polaris area in Delaware County. If passed, this .5% sales tax would be in addition to the existing permanent .5% sales tax. According to the COTA web site, the resulting 1% total sales tax will help the region secure at least \$650 million in additional federal funding, and allow COTA to implement five new rapid transit corridors and increase service hours by 45%.

- **743 Bethel Rd** (GC23-051) this graphics Variance Application to add a third illuminated sign for Coco's within Olentangy Plaza was disapproved at last month's NWCA meeting. The graphics commission was not in favor of Coco's graphics request. It was tabled at applicant's request so they could try to come up with a new graphics plan.
